

COVID-19 MEMBER HEALTH COMPLIANCE AND RULES DECLARATION

Failure to comply with any of these rules may result in disciplinary action imposed at the sole discretion of the Club's Disciplinary Committee or the Board:

- NO VISTORS OR GUESTS PERMITTED ANYWHERE ON CLUB PROPERTY.
- Anyone with signs of symptoms such as a fever or cough or any flu like symptoms must self-isolate and not enter the Club property for at least 14 days.
- Anyone coming into contact with someone who has been infected with the virus, must not attend the Club premises for a minimum of 14 days.
- Anyone recently entering Canada, must follow health regulations, which require a
 mandatory 14 day quarantine. A Club committee will be put in place to assist people (i.e.
 grocery pick up, feed horses while under quarantine, etc.).
- Each Member is personally responsible for staying informed, up-to-date and complying with the health and safety measures imposed by Alberta Health Services

- No group gatherings of more than 15 people are permitted in any circumstance. The 2 meter physical distancing is to be adhered at all times.
- Gloves and face masks are encouraged to be worn at all times while at the Club.
- The Cantina is closed.
- Washrooms are open. Access is available via the Cantina. Lysol/disinfectant wipes are to be used to wipe down taps and door handles after each use.
- The Hitting Cage is open. Lysol/disinfectant wipes are to be used to wipe down the tack before and after each use.
- The Track is open. A mandatory minimum 10 horse lengths between sets. Single riders must keep a minimum 2 metres apart.
- The Arena is open. A maximum of 4 members at any time are permitted at any time. Each person must keep at least 2 metres apart with no physical contact whatsoever.

This declaration must be completed by all members prior to accessing the Club. Failure to do so will result in denial of access to the Club.

We all manage to play by the rules of polo and now we are asking that you observe, just as strictly, our rules of COVID-19 polo. The Club is permitting modified play based on the assurance a member makes to the Club and to each other in this document. The Club appreciates and expects your cooperation to open the Club for riding and polo, and to continue to have the Club available for this purpose. Accordingly, you agree to observe and fully abide by all rules and regulations prescribed by the Club including the rules set forth above. Any failure in this regard will result in disciplinary actions.

As you are aware, the virus can be transmitted by asymptomatic individuals and accordingly the statements made by members contained in this document cannot provide certainty that the virus will not be transmitted. The Club is taking prudent steps to impose and enforce appropriate protocols to keep members and employees safe, but there can be no assurance that the virus will not be contracted by members. This is a risk that each member must assess themselves, and if they choose to play, to take the risk of either contracting the virus or transmitting it to others.
